




#### TRENDS OVER TIME


- 40 States & DC
- 24 states
  (2018-2020)
- 100+ State Laws
- 2 Federal Laws
- 150k-200k fewer children in adult court every year


# RAISE THE AGE

- Reform Blocks the Front Door to Adult Justice System
- Biggest impact in terms of # of youth in adult court (lowering numbers by 150k/year.
- Implementation shows similar findings across states.
- Only 3 states—Georgia, Texas, and Wisconsin remain.




# JAIL & PRISON REMOVAL

- Utilize federal law to incentivize this movement across states.
- PREA (2003)—70% drop in the number of youth in adult prisons.
- JJDPA (2018)—should help remove youth from adult jails get to zero.
- 13k/night down to 3,400/night
- 70% of youth charged as adults already are held in youth facilities pre-trial.



## JUDICIAL & REVERSE WAIVER


Mitigating the Harm

### AUTOMATIC TRANSFER


- "Sleeper" campaign—but critically important.
- 6 states (geographically dispersed) have totally repealed automatic transfer
- Begins to equalize the playing field regarding racial & ethnic disparities



STATES WITH ~200 Youth/Year Charged As Adults

- In all of these states, children charged as adults is decreasing
- NJ & FL have passed reforms
- PA & FL some prosecutors have shifted practice (OH/TN moving in the wrong direction).
- Every state has egregious racial & ethnic disparities
- No correlation between rates of youth violence & charging children as adults.
